

Membership Fee Schedule

of Fist Club Europe e.V.

As of: April 2026 - Adopted by the General Meeting

§ 1 General Provisions

This Membership Fee Schedule is not part of the Articles of Association. It governs the financial obligations of the members of Fist Club Europe e.V. and is issued pursuant to § 8 paragraph 2 of the Articles of Association. It may only be amended by resolution of the General Meeting.

§ 2 Resolutions

1. The General Meeting shall determine the level of membership fees as well as the classification of the membership categories.
2. Amended fees shall apply from January 1 of the year in which the resolution was adopted, unless the General Meeting specifies a different date.

§ 3 Membership Fees

Membership Category	Annual Fee
Voting Membership	EUR 200.00
Supporting Membership	freely chosen, minimum EUR 80.00
Honorary Membership	exempt (Sec. 8 para. 5 Articles of Association)

1. The applicable fee is determined by the member's status as of the due date.
2. The Board decides on the admission as voting member, supporting member or honorary member pursuant to § 4 of the Articles of Association.
3. Honorary members are exempt from the obligation to pay membership fees pursuant to § 8 paragraph 5 of the Articles of Association.
4. In justified individual cases, the Board may, upon written request, waive or defer the membership fee in whole or in part (§ 8 paragraph 4 of the Articles of Association). The decision is final and does not require justification.
5. Changes to personal or organisational details (in particular address, bank account, authorised representatives) shall be communicated to the Board promptly in text form.

§ 4 Due Date and Payment

1. Membership fees are payable annually in advance and become due within one month of confirmation of admission, or at the beginning of each financial year.
2. Payment is made by bank transfer to the association's account. The current bank details are published on the association's website (fist.club) and are communicated to members in writing upon admission.
3. If admission to the association takes place after November 1 of any given year, the member is exempt from membership fees for the year of admission. The full obligation to pay fees commences with the following financial year.
4. If a membership fee is not paid on time, the association is entitled to send reminders. A reminder fee of EUR 3.00 shall be charged for the second and each further reminder.
5. If a member is in arrears with their membership fee for three months and has received a written reminder, the Board may strike the member from the membership list pursuant to § 4 paragraph 5 of the Articles of Association.

§ 5 Resignation from the Association

Resignation from the association takes effect pursuant to § 4 paragraph 3 of the Articles of Association upon receipt of a written declaration of resignation addressed to a Board member. Resignation is only permissible at the end of a calendar month. Refunds of fees or pro-rata fees already paid will not be made.

§ 6 Entry into Force

This Membership Fee Schedule enters into force on the day of its adoption by the General Meeting of Fist Club Europe e.V. It supersedes all previous versions.
